Active Investment Recruitment in India, the US, and Japan

In coordination with the "Promotion of Global Investment in Taiwan" program of the Executive Yuan, the STSP Administration sent representatives to India, the US, and Japan to recruit investors in Taiwan.

Investment Recruitment Efforts in India

From February 20 to 26, the 3 people delegation consisting of the leading Convener, Tung Liangsheng, the Chief of Planning Section for the Hsinchu Science Park Administration, Tsai Chinglang and the Chief of the Investment Section for the STSP Administration, Liang Yuling participated in an investment recruitment mission to India organized by the Council for Economic Planning and Development. The STSP Administration, in order to promote the "Southern Taiwan Biomedical Device Industrial Cluster Development Plan" participated in an investment recruitment mission to the heart of the international medical device industry. From February 21 to 25, the STSP Administration convened conferences in the capital

city of India, New Delhi, the largest financial center in India, Mumbai, and a newly emerging city in India called Ahmedabad. These conferences attracted the participation of many large scale enterprises represented by over 1,000 attendees who provided a great deal of positive feedback. Investment Recruitment Efforts in the US

The 3 people delegation was led by the Deputy Minister of the National Science Council, Jou Jingyang and included the Section Chief of the Hshinchu Science Park Administration, Li Shumei and the Chief of Investment Section for STSP Administration, Chen Chinyu. From May 16 to 20 respectively, conferences on Global Investment in Taiwan were organized in 3 US cities: New York, San Francisco, and Los Angeles. Deputy Minister Jou Jingyang presented the Hsubei Biomedical Park and the Biomedical Device Industry Cluster Plan at the STSP while Chief Li Shumei and Chen Chinyu provided attendees with relevant advice regarding investment in the biomedical device industry as well as grants and subsidies.

Investment Recruitment Efforts in Japan

The "Investment Recruitment Mission to Japan," organized by the Executive Yuan for the "Promotion of Global Investment in Taiwan" program was led by the Minister of the Council for Economic Planning and Development, Christina Y. Liu. The mission delegates were composed of 230 representatives of governmental agencies and industrial leaders including the Section Chief of the STSP Administration, Chen Chinyu. In 4 events from August 29 to September 2, the delegation invited Japanese enterprises to invest in Taiwan and was engaged in visiting activities. The delegation went to Tokyo and Osaka and convened a 1 conference on "Investing in Taiwan" to introduce investment opportunities in Taiwan. Moreover, representatives from different industrial sectors visited about 40 well-known Japanese enterprises to promote strategic alliances between Taiwan and Japan in order to take advantage of newly rising Asian business opportunities.
